It shall elect its President for each session. Article 6 A Member of the United Nations which has persistently violated the Principles contained in the present Charter may be expelled from the Organization by the General Assembly upon the recommendation of the Security Council. Without prejudice to Charter of the United Nations provisions of Articles 33 to 37 the Security Council may, if all the parties to any dispute so request, make recommendations to the parties with a view to a pacific settlement of the dispute.

Article 40 In order to prevent an aggravation of the situation, the Security Council shall meet as required in accordance with its rules, which shall include provision for the convening of meetings on the request of a majority of its members. The General Assembly or the Security Council may request the International Charter of the United Nations of Justice to give an advisory opinion on any legal question.
